Narrative & Statements

Narrative - Archer, Kevin - 9/12/2024 5:08:04 PM (Initial)

On 09/11/24 at approximately 1700 I, Patrolman Archer was dispatched to Millcreek for a staff member who wanted to report his Silver Macbook Pro (MR4NPNQMT4) stolen. Once I arrived at the facility I made contact with [REDACTED]. [REDACTED] stated that he had his Macbook at work and locked and placed it in the back office so no one could mess with it. [REDACTED] stated that [REDACTED] and [REDACTED] came on shift, and worked their shift. When [REDACTED] arrived for his shift he saw his Macbook was gone he pinged its location from his phone and it pinged at [REDACTED]. [REDACTED] Mr. [REDACTED] attempted to retrieve the Macbook himself and went over to [REDACTED] Residence and spoke with him to return the Macbook, so he wouldn't have to get the police involved. [REDACTED] stated that he did not have the Macbook. After [REDACTED] left the residence, he returned to work and called the police. [REDACTED] stated that after he contacted dispatch he checked the live ping again and the Macbook had been turned off but the last known ping was still at [REDACTED].
