Residents were separated and [REDACTED] was moved to another Hall. Both Residents were interviewed by the Safety team morning of 09/18/2024. Both Residents verbalized no intention to pursue physical altercation. Resident returned to milieu same day at 2054 (8:54 pm) without issue. Resident is on activity restriction until assessed by ENT Doctor. ENT appointment forthcoming.

Camera footage of the "300" hallway was reviewed for 9/17/2024 at 17:15-17:18. The residents were seen on the hallway with staff in ratio. The resident and other boys had entered a bedroom at the end of the hallway. Staff can be seen entering then exiting a short time later with the resident who is injured. The resident is taken to the nurse's station for treatment, then sent out to the hospital for an Xray of his nose.

The resident and the peer were placed on peer restrictions and assault precautions following this incident.
