Report Description: On 9/24/24 [REDACTED] at approximately 1120 was refusing outside, took his shoes and socks off and while staff was processing with him, resident went over the fence and ran towards the apartments next to the facility. Staff attempted to follow but he could not be located. Fayetteville police department was called at 1128. Resident was brought back by Springdale Police at 1604, skin assessment was completed and Resident had a small abrasion on top of right foot, no bleeding noted. He was placed on elopement precautions and restricted to unit to be re-assessed at 24 hours. He will also process with primary therapist. [REDACTED] saw the APRN the next day, an xray for left foot was ordered after he reported that he jumped down a bridge while out of facility unauthorized.
