ratio of 2:12, but a third staff entered shortly after video started. The two boys can be seen becoming escalated as staff attempt to de-escalate the situation. One boy approaches a peer and quickly throws one punch to his face. The two begin to fight and staff attempt to intervene falling backwards and they pull the residents apart. The residents were separated and placed on assault precautions.
