Pt was walking around the milieu as staff tried talking with him. Pt began trying to break down the back door. 2:55pm Personal Restraint: Pt began trying to break open the door by ramming it and was placed in a personal restraint. Pt is screaming and threatening to kill staff. Pt is struggling and spitting as staff are trying to talk to him. Another peer walks out of his area trying to help fight staff. 3:01pm Personal Restraint End: Pt has stopped struggling and and agrees that staff can release him. Pt contracts to go to his area and is released from the personal restraint. 3:02pm Other/None: Pt immediately begins walking around the milieu, not returning to his area as he contracted to do. Pt goes over to the TV and begins pulling on the cord of the TV and is told to stop. Pt does not. 3:04pm Personal Restraint: Pt is placed in a personal restraint due to his aggressive behavior. Pt is struggling with staff. Staff are trying to talk with Pt but Pt continues to yell and threaten staff. 3:07pm Chemical Restraint: Due to the PT's continued aggression, Pt is given a chemical restraint by the nurse. 3:08 Personal Restraint: Pt continues to struggle, trying to kick and head butt staff. Staff continue trying to talk to the Pt. 3:20pm Personal Restraint: Pt has calmed somewhat and agrees to let the staff get off his legs. Staff continue talking with him. 3:22pm Personal Restraint End: PT again contracts for safety and to return to area. Staff release him at this time. Patient Debriefing date/time: 09/26/24 4:00pm: Pt was brought more comfort items and later approached staff and apologized for his behavior. Staff told PT that they had to keep him and everyone safe. Nursing Assessment date/time: 09/26/24 3:30pm: Client came home from school very excited with peers. Client quickly turned angry and tried to barge out of the door. Client was restrained for threat to safety. Client continued to struggle with staff to be released from restraint. Client yelled out that we were racist. Client was released and placed in another restraint shortly after. Client yelling and struggling with on the floor. Client was given IM Thorazine 50mg right gluteus maximus. Client continued to struggle, said he will punch me. Client began to calm down and was released from restraint. Client states that he is mad and sad and anxious. Complains of pain to right forearm and right gluteal muscle. Ibuprofen x 2 administered. Client was provided peapod to decrease anxiety. Client is alert and oriented, has full/active ROM all extremities. Client is calm and cooperative at this time. Client was easily awakened around 8:40pm, packed a bag and was taken to acute around 9pm via agency staff and van. Guardian was notified on 09/26/24 at 4:26pm, 4:27pm, and 4:30pm was transported to BridegeWay for an acute stay on 09/26/24 at 9:01pm.

Interim Action Narrative: Resident was placed in a restraint for safety, assessed by the nurse, and transported to acute care.
