**On 10/1/2024, at approximately 5:04 PM I was dispatched to 4253 N. Crossover Road (Piney Ridge) for two runaway juveniles.**

**I made contact with the reporting party, Anna Moore W/F [REDACTED] (PH: [REDACTED]). Anna stated [REDACTED] and [REDACTED] jumped a fence and ran away.**

**[REDACTED] was described as being 5'4" tall and 151 lbs with blue eyes and blonde hair. [REDACTED] was last seen wearing a black jersey with "Rick and Morty" on it and black jeans. [REDACTED] was described as being 5'6" tall and 127 lbs with brown eyes and black curly afro-style hair. [REDACTED] was last seen wearing a red t-shirt and black jeans. Both juveniles were seen running north toward Springdale. There were no special considerations for either individual and no known scars, marks, or tattoos. Officers searched the area but did not locate the juveniles. Neither juvenile has any known local friends or family.**

**I requested records enter both juveniles and missing and had dispatch disseminate a BOLO.**
