On 10/2/24 a report was received from Arkansas DHS in regards to a new report.

The DHS snapshot was reviewed and the following is a summary of the report.

AV is [REDACTED]. PRFC is [REDACTED]. PRFC/AO is [REDACTED]. [REDACTED] is a resident of Perimeter Behavioral of the Ozarks and [REDACTED] is a staff member. On 9/30/24, staff received a grievance form stating, "[REDACTED] put bruises on me." For context, this resident has been involved in four restraints since 9/26/24 with various staff members. Each restraint was reviewed by camera by multiple leadership personnel and no misconduct was noted. Additionally, [REDACTED] was medically assessed after each incident and did not present with bruising.

Description:

I called and spoke with Cathey Coleman who advised that she had responded to the report but that it was assigned to another case worker who was out. Cathey advised that she spoke with staff who said that they had received multiple reports from [REDACTED] alleging physical abuse and that none had been verified. Staff said that [REDACTED] had been suspended during their investigation as part of their policy. One incident was observed where [REDACTED] had restrained [REDACTED] during an active fight between [REDACTED] and another resident. [REDACTED] only ever restrained [REDACTED] and did not strike her. Lastly Cathey told me the only the only injury observed were bruises on [REDACTED] biceps and were consistent with [REDACTED] restraining her. I requested video and images when they were obtained, and I have not received anything at this time.

Due to video footage only showing [REDACTED] restraining [REDACTED] as part of his job and no evidence of abuse, I am closing he case as inactive and submitting for supervisor review. Once the video footage is recieved the case can be reopened if there is evidence to the contrary.
