Vitals were normal and EpiPen administered at 0945 (9:45 am) with improved results. EMS arrived at 0950 (9:50 am). No evidence of peanuts on premises or peanut consumption based on camera review, food inspection, Resident interview and peer interview. Resident returned to milieu same day at 1430 (2:30 pm) without further issue.
