Resident climbed the fence and eloped while outside, staff tried to intervene but Resident was able to jump the fence, staff had eyes on Resident for while and lost sight of him, Fayetteville police called at 1405, AOC made aware, and guardian called and notified at 1420, Resident was found by the outside gym and was brought back to the facility at 1525 by Piney staff, skin assessment and gown search completed, Resident sustained two abrasions to his right hand while climbing the fence, wound care completed and Resident placed on elopement precautions X 24 hrs. Resident will process with his primary therapist.

Maltreatment Narrative:		

Licensing Narrative: 10/8/2024 - The provider reported incident was reviewed by the licensing specialist. Licensing specialist will follow up with the facility in regards to nursing notes and staff intervention with a follow up visit under inspection #081011. The facility has removed the awning to prevent future incidents where residents can climb the awning and scale the fence. Supervision was discussed and it was noted staff saw the resident and attempted to stop the resident with verbal redirection. Physical restraint was not used for safety concerns and the resident was out of reach. 10/10/2024 - Facility response received:

"So related to elopement? it depends on situation to the decision of how to intervene." Facility staff provided a copy of elopement polices and procedures for dealing with elopements. Documents were reviewed, and uploaded to ELS

A visit was conducted to follow up on self reported incidents: 024555, 024556, 024562.

In regards to case024555 an inspectionwas conducted of the out door area where the resident used the awning to scale the fence surrounding the outdoor area. Upon arrival facility staff were in the process of deconstructing the metal awning and removing the structure from the facility in order to prevent residents from climbing on the awning as a preventative precaution. Staff supervision was discussed concerning the event and the resident was seen and verbal redirects were attempted to stop the resident from climbing the awning. No physical restraint was used as a safety precaution because the resident was out of reach.

In regards to case024556 which was linked to case 024360. Nursing notes and hospital discharge information have been uploaded to ELS under case 024360.

In regards to case 024562 - The incident was discussed with facility staff and nursing notes will be provided to licensing for the report incident.
