Report Description: At approximately 17:00 unit supervisor received a call from Fordyce Police Department reporting that a patient had broken into a house and they needed to return him back to Millcreek. Staff went to the residence and found patient sitting in a vehicle. Patient stated that the car battery was dead, so he was just sitting in it. Patient stated that he crawled under the fence while the unit was outside and staff weren?t looking. Patient was returned to Millcreek and searched for contraband. Patient has been placed on suicide precaution due to patient stating that he wanted to kill himself. Staff that was assigned to will be terminated on 10/14. Interim Action Narrative:

Facility visited in response to incident in which client eloped from Millcreek and broke into a residence. Staff/client ratio at the time of this incident was 1:6. Millcreek staff was not aware was awol until notified by Fordyce Police Department. Facility cited 907.2 for staff not supervising for the amount of time it took for to elope from facility, travel to and break into a residence. Staff responsible for supervising was was terminated from employment immediately following this incident.

Provider Comments:

We remain fully committed to the safety of everyone in our care. Resulting from this incident, we identified a small area of the fence that could be pulled back, and this will be secured immediately. Additionally, staff involved in this situation have been terminated for failing to uphold our patient safety standards.
