On Tuesday, November 5, 2024, at approximately 1320 hours I received a call for service from the Crimes Against Children in reference to a sexual offense.

I made contact with Ms. Suzie Roberts (Complainant) via telephone who advised me that there was a sexual offense that occurred at 161 Skunk Hollow Road (Little Creek Behavioral Health). Mrs. Roberts stated JV1(A.V.) was roommates with JV2 (E.S.) and alleged that on approximately October 27, 2024, they were sleeping in their room. Ms. Roberts stated that JV1 alleged that JV2 came over to her bed and stuck her hand under clothing to touch her naked person. Ms. Roberts stated that JV1 alleged that JV2 put her hand over her mouth when tried to say something and left. Ms. Roberts was able to provide the ages of both JV1 and JV2. JV1's approximate age is ██████████ and JV2's approximate age is ██████████ Mrs. Roberts stated there was nothing that occurred following the touching of the breast area by the hand of JV2.
