Ms. Roberts stated that JV1 alleged that JV2 came over to her bed and stuck her hand under clothing to touch her naked person. Ms. Roberts stated that JV1 alleged that JV2 put her hand over her mouth when tried to say something and left. Ms. Roberts was able to provide the ages of both JV1 and JV2. JV1's approximate age is approximate age is Mrs. Roberts stated there was nothing that occurred following the touching of the breast area by the hand of JV2.
