Report Description: Incident Reports for client in our PRTF program and resides in Rose House Incident Report 1 date/time: 10/28/24 5:54pm Location of Incident: Rose House Incident Description: Self Injury (Not Suicidal), Aggressive to Adults, Threat to Safety Staff Involved: Brittney Hubbard, Brayjana Pettigrew, Joseph Davis, Ashley Sims, Tyreesha McCollum, Zharieah Foreman, Matthew Chrysler Events Leading: Client was escalated since the beginning of the shift and non compliant and not following staff directions. Client earlier in the day was jumping on furniture, not staying in her area, grabbing things that did not belong to her, scratching her cuts and making them bleed, banging on tables and chairs and putting objects over her face and head. Client reported she was hungry and this is why she was acting out. Client then continued to escalate and began walking around the room and not following directions. Client continued to scratch her scabs and cuts. Client would not comply and continued to do unsafe behaviors and would not accept redirection. Client began tearing things off the wall. 5:55pm-Personal Restraint: Client was placed in a sitting personal restraint by staff due to increasingly escalated behaviors and unstable, unpredictable and unsafe behaviors when beginning to pull things off the wall after her continually being a threat to safety. Client began sliding herself into the floor so staff followed and continued with a floor restraint. 6:00pm-Personal Restraint End: Staff began to let go of the client to see if she was going to be compliant and contract for safety. 6:01pm-Personal Restraint: Client rolled on to her back and began attempting to self harm by biting her hand and then began kicking staff near her legs and staff restarted the restraint. 6:11pm-Personal Restraint End: Client began calming down and not resisting her restraint and contracted for safety so staff began letting go and allowed the client to sit up in the floor to further deescalate. Patient Debriefing date/time: 10/28/24 6:30pm: Client was still very upset and was begging staff and her therapist to not make her go to acute. Client continually repeated "please don't let them take me, I promise I'll be good." Nursing

Assessment date/time: 10/28/24 6:30pm: Client required personal restraint due to self
harming. Upon my arrival, client was on the floor in active restraint, struggling with staff.
Client yelled out, continued to struggle with staff and look behind her frequently. Client was
partially released and she pulled her hair and/or bit on her own hand. Personal restraint was
restarted. Client eventually calmed down and was released from restraint. Client tearful,
pleaded with therapist no to go to acute. Client has no obvious new injury from this incident
and has no obvious injury noted. Alert and oriented, gait steady, full/active ROM all
extremities. Denies injury. Client left via MEMs around 6:30pm for acute. Guardian was
notified on 10/28/24 at 6:34pm Incident Report 2 date/time: 10/28/24 6:25pm Location of
