While staff were intervening joined into help the resident being assaulted fight and was kicked by in the stomach. started throwing up and reporting intense pain. The nurse called EMS at 17:25 and was taken to the ER for evaluation. The resident had a urinalysis and x-ray done showing no issues and was discharged from hospital at 20:32. Nursing staff of Perimeter continued to monitor resident throughout the night to make sure there were no new complications or issues. Resident does not report any pain as of today 11/11/24 and has no injuries. Actions Taken: MR was sent to the emergency room for evaluation. Nursing continued to monitor resident upon return for any complications.
