Upon arrival I met with Kris Teel who advised the blue pod was fighting. I went back into the pod and the staff had multiple juvinile females in holds on the ground. No staff was able to tell me what had happened. After the pod had calmed down I sat down with Mr. Teel the RN in charge at the time and he advised me that some of the girls in the pod were talking about each other and a fight broke out. Mr. Teel was unable to tell me who started it and who all was involved. Mr. Teel stated that he does not believe there was blood being spat up but that the Victim who I identifed as had eaten hotdogs for diner just a few moments earlier had mashed them up and spit them up pretending it was blood. but it was unconfirmed. was transported to childrens hospital for evaluation.
