Report Description: On 11/18/2024 at approximately 0710 [REDACTED] became escalated, was attempting to attack a peer and staff attempted to place the resident in a physical hold but resident slipped out. Because of this, staff released resident completely and stepped away. [REDACTED] continued to engage in unsafe behaviors and when placed in a hold again he punched a staff member Brandon Barrett in the face. He was eventually able to calm down, process and take his PRN medication. On 11/19/2024 the staff member contacted the Fayetteville Police Department and pressed charges on the resident. At approximately 1810 the police department arrived and transported the resident to juvenile detention.

Licensing Narrative: 11/21/2024 - Licensing reviewed the report and will follow up with the facility regarding if the resident has returned. The facility provided a statement for the late report date: "I placed an arrest of a resident in the portal a day late (entered on 11/21/2024, we do not have residents arrested very often at the facility therefore I forgot to report in portal on 11/20/2024. I apologize for this oversight." Program Coordinator requested police documentation. 11/22/2024 - Licensing specialist inquired if there was video footage

available. Facility states there is not video footage available. Licensing specialist requested witness statements for the incident from residents and staff who saw the incident. Police documentation received and Licensing Specialist informed. Facility cited for 110.17 - 521 report sent to the facility for signature.

This is not a common incident to have a youth arrested and the facility made an error, but still made the self-report as soon as we caught our own mistake. We will do our best to ensure we meet the standard in the future.
