On November 21, 2024 I Officer Terrell and Officer Grier responded to a call at Ashley County Medical Center in regards to a run away Juvenile wearing a yellow sweat shirt and blue pajama pants. We started searching the surrounding areas when dispatch

notified us that she was seen in the Walmart parking lot. Officer Grier spotted the juvenile in front of the grocery doors at Walmart. Upon her approach the juvenile then took off running where i cut her off with my truck,

After making the initial contact with the JUVENILE trying to understand what is going on and during the investigation I spoke with Kristy Higginbotham (01-12-78) and Dorothee Smith (10-02-63) and they both advised that she was admitted to the Delta Counseling

Facility in Hamburg, Arkansas by her guardian. Her Guardian was notified and she was supposedly on her way from Mayflower, AR. The reason for her to be admitted in the hospital is that the JUVENILE allegedly swallowed a screw. During the process of the

doctors doing their examination and trying to transport to Arkansas Children's Hospital, the JUVENILE decided to run out of Ashley County Medical Center.

After coming to the conclusion that the JUVENILE'S Grandmother admitted her into Delta Counseling Facility, we escorted the JUVENILE back to ACMC to finish the remaining treatment. While we are there with the JUVENILE she starts kicking and acting irate

in the hospital. We kept her hands restrained due to fact that she was uncompliant and attempting to assault anyone near her. While sitting with the JUVENILE we had to constantly tell her to sit down, to quiet down,

and to stop kicking us. We did not have access to leather restraints nor leg shackles to restrain her more. The doctor then ordered a shot to help clam her down. My self and Officer Grier then assisted the nurses in lying her on the bed so the shot could be admin
