Report Description: On 11/23/24 Client [REDACTED] was involved in an incident with a staff member [REDACTED] from around 4:53pm on the boys unit foyer, [REDACTED] got into staffs personal space and staff put his hands around clients neck. Staff lets client up, client goes back towards the staff, and staff does an improper hold floor restraint on the client holding him down with his arms and knee into the client's chest. Client gets up and staff puts him into another proper floor restraint holding him down by the table. Staff lets go, and client goes after staff again and you see staff take client to the ground again with the staffs hand around clients neck. Another staff member comes out of office and tries to get staff [REDACTED] to release him. Staff [REDACTED] goes after client again in the floor holding him down. Staff [REDACTED] leaves the area and is seen going into the office, [REDACTED] Follows shortly after. At 5pm, staff comes out of the office, and [REDACTED] has two towels in his hands. pacing around the donut couch, eventually coming back into staffs personal space and swinging the towels and trying to go after staff, [REDACTED] grabs [REDACTED] and throws him on the couch, you over hear [REDACTED] saying let go, removing staffs hands, and saying you have to put him in a restraint. [REDACTED] holds [REDACTED] by his arm and has client follow her out of the foyer away from staff [REDACTED] is suspended. [REDACTED] will have training on proper communication skills when needing to contact a supervisor during a crisis

Another staff member did come in the foyer when the resident began yelling and screaming but failed to seek additional assistance during the incident.




