Ms. Roberts advised two JOs went into JV's room, placed him into multiple positions, spanked him on the butt, pulled his pants and underwear down, put his underwear back up, and one of the JOs inserted his figner through JV's underwear and into his butt. JV then told one of the staff members of the incident and expressed that he was scared.
