- [REDACTED] advised that [REDACTED] was going to go to jail and she didn't want him to.
- Christina advised that she didn't know who [REDACTED] was.
- [REDACTED] asked why we were here and Christina told her that she had been informed that something had happened that [REDACTED] wasn't okay with.
- [REDACTED] advised that there was supposed to be an investigation on [REDACTED]
- Christina asked rapport building questions and [REDACTED] advised that she liked to crafts.
- [REDACTED] advised she was from Dallas and her caseworker was her guardian.
- [REDACTED] advised she shared a room with [REDACTED] for approximately a week but had shared a room with [REDACTED] and she was the reason we were here.
- [REDACTED] advised that [REDACTED] told her to "fuck her" and "I was scared" that if she didn't, she would fight.
- [REDACTED] advised she touched her private area.
- [REDACTED] advised that [REDACTED] told her that her hormones were kicking in and asked if [REDACTED] liked girls. [REDACTED] advised she told [REDACTED] that she didn't like girls in mental hospitals.
- [REDACTED] advised that [REDACTED] told her to sit on her bed with her and that she felt threatened and felt she was going to fight her.
- [REDACTED] advised that [REDACTED] was the only real one she had and that she was in love with someone older than her.
- [REDACTED] advised that she was going to tell no matter what happened.
- [REDACTED] advised that [REDACTED] kissed her on the lips and [REDACTED] told [REDACTED] to suck her "titties" and I felt threatened and that she would fight me.
- [REDACTED] advised that [REDACTED] had threatened to fight her after the incident in class because she found out that [REDACTED] had told someone they were dating.
- [REDACTED] advised that [REDACTED] was touching her in her private area on the skin.
- [REDACTED] advised that [REDACTED] told her to pull her pants down and [REDACTED] pulled her pants and [REDACTED] touched her private area with her hands.
- [REDACTED] advised that it happened two days.
- [REDACTED] advised she sucked on [REDACTED] "titties" and she stopped because she knew she was doing something wrong and [REDACTED] hands were on her lap and [REDACTED] hands were on her "titties".
- [REDACTED] advised she decided to tell because she was [REDACTED] and [REDACTED] was [REDACTED] and that because she was older, she didn't want the charges to fall on her and that she already had charges.
- [REDACTED] advised that [REDACTED] had said in the classroom that she was going to fight [REDACTED] but did not say it to her face.

I spoke with both the girls' case workers and both girls have history of being sexual aggressors and that [REDACTED] has made similar claims at other placements. The judge ordered a lock down facility (Perimeter) since she has a history of running".

On December 3, 2024 at approximately 4:44PM, I (Detective Whitaker #393) reviewed case 24-76780.

Due to being denied consent to speak with the alleged suspect and the alleged victim having an history of being a sexual aggressor as well as her stating in her interview that she didn't want the charges falling on her because she was older and that's why she decided to tell, I have not been able to prove forcible compulsion or physical helplessness that would be required to pursue charges. Therefore, I am forwarding this case to be reviewed to be closed.
