

Licensing received a provider reported incident on 12/10/2024 for ELS Case #025996.

Licensing Specialist reviewed camera footage for this provider reported incident with Kaylynn Barrett and Sherika Williams staff members of the facility. The ratio was 2:1. The incident occurred at about 5:28:34 p.m. and ended at 5:28:57 p.m.

This alleged incident was reported on 12 /08/2024. Licensing viewed the camera footage and observed the incident occurred as the residents were walking up the stairs from the cafeteria on their way back from dinner. It was reported by the facility that a staff member asked two residents what they were laughing at and one of the residents responded "You." The facility reported that the staff member responded with an inappropriate response of "girl find you someone else to play with your own age." It was reported by the facility that the client made a threat to the staff member with a comment of "I will punch you dead in your face". The facility reported that the staff responded by saying "I will beat you with this walkie too". It was reported by the facility that the resident and staff both made inappropriate comments to one another and the comments were heard by the specialist during video review. Licensing viewed the resident walk through to enter another room when a pair of glasses were viewed in the air, but the camera footage did not provide an angle to view what was taking place between the resident and the staff member.

The facility will be cited for the following:

905.4.g "The following disciplinary actions shall not be used: (g) Physical injury or threat of bodily harm" due to the staff member stating to the resident "I will beat you with this walkie too". 110.9.a "Any owner, operator, employee, foster parent, or volunteer in a child welfare agency shall immediately notify the Child Abuse Hotline if they have reasonable cause to suspect that a child has: (a) Been subjected to child maltreatment" A/O is currently on leave pending the investigation. Staff and shall be retrained on mandated reporting by 12/27/2024.
