At 11:32, [REDACTED] entered the Gymnasium and immediately headed toward a perimeter door. Once outside, she climbed the fence and took off running. Multiple staff responded to the staff support and the Springdale Police Department was called once it was determined she left company grounds. [REDACTED] was escorted back to the facility at 11:52. **Actions Taken:** ? [REDACTED] was assessed by EMS; no injuries noted. ? Member placed on elopement precautions and

restricted to unit. ? [REDACTED] had an ad hoc session with a therapist. ? Gym use was restricted to prevent imitation.

Time stamp for the review 12/11/2024 - 11:30 AM - 11:52 AM The camera footage review is in the gym. Staff to resident ratio 2:8. Resident can be seen coming into the gym at 11:32AM. [REDACTED] can be seen moving into the gym and running towards the door and going outside. Staff noticed the resident leave when she exited and began running towards the door. Staff from across the hall inside can be seen responding as support. Staff move residents back into the hallway. 6 staff responded to the elopement and police were called. The resident crossed the highway and was intercepted by Springdale Police about a half mile away from the facility. Resident was returned to the facility at 11:52 AM. In response to the incident the facility has spoke with the Fire Department on allowing the door to be locked. The door leading outside will now be supervised more during gym time. The resident has been placed on elopement precautions till further notice. 12/23/2024, police documentation requested During visit licensing specialist discussed measures to ensure the residents are not the first one into the gym during recreation time.
