Description:

On 12/18/2024 at approximately 1000 hours I was dispatched to an Assault/Battery at Perimter of the Ozarks at 2466 S 48th St B. The caller stated that on 12/17/2024 her daughter had been assaulted by another female at the facility. The caller identified herself as [REDACTED] the young girl's mother. [REDACTED] stated that her daughter is [REDACTED] years of age and the girl that assaulted her was [REDACTED] years of age. [REDACTED] stated that her daughter has scratches all over her face and would like to make a report and have pictures taken of the injuries her daughter sustained.

Upon my arrival I made contact with a female she identified herself as [REDACTED] (W/F DOB [REDACTED]). [REDACTED] stated that she wanted to tell me what happened to her the day before.

I asked [REDACTED] to tell me what happened. [REDACTED] stated that she was asking to see if they could watch a YouTube Channel and this female she identified as [REDACTED] (F DOB [REDACTED]). [REDACTED] stated that [REDACTED] came up and stated that [REDACTED] is RTU (Restricted to Unit) and she was not allowed to pick what they watched. [REDACTED] stated that she turned away from [REDACTED] and looked at the staff and stated "Anyway", can we watch that channel.

█████ then went on to state that when she did that, █████ became very aggressive stating she is about to go crazy "to let her go". █████ stated that █████ pushed her way through 2-3 staff members to get to her. █████ stated that the staff was unable to stop her and when █████ reached her she immediately began punching her in the face and neck. I asked █████ if █████ punched her with a closed fist. █████ stated it was a closed fist. █████ stated that █████ had punched her a total of three times.

I asked █████ how she received the scratches to her face. █████ stated that when she got the attitude with █████ and █████ was able to get to her she started scratching her face with her nails. I observed large scratches to the left side of █████ face. One scratch was from her forehead to the middle of her left eyelid. She had scratches on her nose and throughout her cheek.

█████ stated that she also has scratches just right behind her left ear when █████ grabbed her by the hair and pushed her down to the floor. I observed 3 scratches behind the ear. Two scratches were just behind the ear and 1 scratch was just inside the hairline.

█████ stated that █████ had a hold of her hair on the left side of the top of her head and when the staff kept trying to pull █████ away from █████, █████ pulled out a chunk of hair. I observed some redness on the left side of the top of her head some redness and sores from what looked to be consistent with hair pulled out from the roots.

I asked █████ if her and █████ have ever had any issues before now. █████ stated that they have been in small verbal arguments "not screaming matches". █████ stated that they have always been able to work out their differences.

█████ stated that after the staff separated her and █████, █████ stated "I'm on site", "I'm going to get you back".

█████ stated that they used to be in the same unit until 12/17/2024, █████ has remained in the "Blue Unit", and █████ has been moved to the "Green Unit". █████ stated since the staff was quick to move her from her unit she felt a little more safe. █████ stated that when you are in a different unit they keep each unit together and not mix units. █████ stated since █████ is 17 years of age she is in a different class room.

█████ stated that she believes someone in the staff had told █████ that █████ was talking "trash" about her and this is how the whole verbal and physical altercation started.

When I called █████ (Mother) back she stated that she is wanting to press charges on █████ for assaulting her daughter. I advised █████ that I would making a report on her behalf for Assault 2nd.
