Report Description: Around 1800 on 12/17/24 [REDACTED] reported to a staff member that he thinks the first week of December that two other residents, [REDACTED] and [REDACTED] [REDACTED] ) had engaged in some type of sexual behavior that he did not actually see. On 12/18/24 the therapist, Kenny Rummell met with [REDACTED] and he stated first that [REDACTED] digitally penetrated him when he said "no" and then later said that he penetrated him with his penis. [REDACTED] reported to his therapist the exact opposite and stated that [REDACTED] tried to penetrate his anus but did not accomplish it. Both stated that they told the other resident "no" and the other resident did the behavior. They also stated that this was brief and that when they heard the staff member walking down the hall they both went to their perspective rooms. [REDACTED] [REDACTED]. [REDACTED] of the [REDACTED] was assigned to one of the cases, the other [REDACTED] worker is unknown at this time.

Licensing Narrative: Licensing specialist reviewed the report. Licensing will reach out to [REDACTED] [REDACTED] for permission to contact the facility in regards to location of the alleged incident, video footage review and safety plan. 12/20/2024 - Permission requested from [REDACTED] Permission was granted to follow up with the facility for safety plan implementation and video footage availability. Facility response received: "The residents are on SAO precautions, no interaction, one of the residents has moving to a different unit, we have contacted both guardians and received approval from guardians for STD testing. I have already confirmed that the residents are not in the same classroom rotation. In addition, both primary therapists are aware of the allegations. Unfortunately, the youth do not know the date nor have they given a clear timeframe. Our team is still investigating this but this has slowed on our end since Washington County is involved and we want to respect their investigation. We do not have camera footage based on not having the timeframe of the investigation. 2/13/2025, per [REDACTED]. Licensing Specialist informed. 2/14/2025 - The complaint is UNFOUNDED by licensing. 521 sent to facility for signature.
