on 12/22/24 I, Ptl Hawkins responded to a call Perimeter Behavioral facility at 1521 Albert Street in reference to an employee needing to file a report after being assaulted by one of the juveniles at that facility. Upon my arrival I made contact with the victim (Trey Smith). Mr. Smith stated that [REDACTED] knocked the headliner of the ceiling down and found a brick inside of it. Mr. Smith also advised that [REDACTED] then took that brick, ran down the other end of the hallway, busted out a window and began to cut himself with a piece of the broken glass from the window. Mr. Smith stated that he tried to intervene by stopping [REDACTED] from harming himself, but [REDACTED] then began striking him with the broken glass causing laceration to his right shoulder and arm. Mr. Smith advised that he was able to take the glass away from [REDACTED]. Mr. Smith advised that he didn't medical attention but he wanted a report on file as his job requires.
