Please describe the incident: On 12/27/24, [REDACTED] eloped off grounds and was returned to the facility by the Springdale Police Department. At 12:40, [REDACTED] scaled the Courtyard fence and took off running. Multiple staff responded to the staff support and the Springdale Police Department was called once it was determined she left company grounds. At 13:30, [REDACTED] was picked up less than a mile from the facility and escorted back. **Actions Taken:** [REDACTED] was assessed by nursing staff and treated for a 4-inch scratch on her right leg and a 1-inch scratch on her left leg. Member placed on elopement precautions (restricted to unit, paper scrubs, line of sight constant). Courtyard use was restricted to prevent imitation. Guardians informed of her return. Staff receiving remedial elopement prevention training.

Staff saw the resident scale the fence and immediately called staff support. Five staff responded. "

Narrative:

Program Manager completed a review of case 026476. Camera footage was reviewed for the elopement on 12/30/2024 between the times of 12:10pm to 12:39pm. Below is a recap of the video footage.

12:10pm- Video starts

12:13pm- 2 staff and 6 residents can be seen exiting the building to go into the courtyard.

12:25pm- 1 staff exits the building and comes onto the courtyard making the ratio now 3:6.

12:26pm- 1 staff can be seen leaving the courtyard returning the ratio to 2:6.

12:39pm- 1 staff can be seen escorting a resident to the door of the building to be allowed into the restroom (per facility). Once the staff is close to the building, the resident who eloped can be seen quickly scaling the fence on the far side of the courtyard and jumping over before taking off running. The staff who was on the courtyard immediately called for staff assistance and five additional staff immediately exit the building in response as they come onto the courtyard.

The facility reports the resident was gone for approximately 40 minutes before being found approximately 1 mile down the road by police at a local Wal-Mart. The resident was returned without incident and placed on elopement precautions.
