On Friday, December 27, 2024, at approximately 12:58pm, I responded to Perimeter or the Ozarks located at 2466 S 48th St for a runaway call.

Upon my arrival, I made contact with one of the nurses, identified as Hunter Vanburnt DOB [REDACTED] and I asked him what happened. He stated that one of the patients there, identified as [REDACTED] DOB [REDACTED] ran away at approximately 12:38pm. He stated that staff last saw her jumping the fence and walking southbound from the specialty care facility. Hunter stated [REDACTED] was brought her from South Dakota and she had to be escorted because she was an escape risk. He stated that she is also possibly suicidal and may have violent tendencies towards law enforcement.

I then asked him to describe her and he stated that she is an American Indian female, but she looks [REDACTED]. He stated that she had on a black or dark gray sweatshirt and what he thought were Winnie the Pooh pants, which were later found out to be Hello Kitty pants. Hunter also stated that [REDACTED] would have scars on both of her forearms from previous self-harm incidents. He stated that [REDACTED]. He stated she also takes [REDACTED]. Hunter stated that she may have social media accounts, but the patients there have limited access to any social media. He stated that [REDACTED] parents did tell them that she had a very light footprint on social media, though. Hunter also stated that she was transferred here from South Dakota on [REDACTED] so she isn't too familiar with the area and it is unsure of where she would go.

While I was speaking with Hunter and gathering information, dispatch advised that another person called in and advised that [REDACTED] was at the Walmart Neighborhood Market down the road from the facility. Other officers responded to the market and were able to locate [REDACTED]. They then brought her back to the facility and I advised Hunter that I would file a documentation report for this incident. A photograph of [REDACTED] was taken from body camera footage and uploaded to the server in the event that [REDACTED] runs away in the future. WIM 359
