Licensing received a provider reported incident on 12/31/2024 for ELS Case #026506.

Licensing Specialist reviewed camera footage for this provider reported incident with Kaylynn Barrett, Sherika Williams, and Fatima Stepps at the facility.

This alleged incident was reported to Licensing on 12/31/2024. Licensing observed according to the camera footage, the incident occurred on the boy's floor in the foyer area at 5:24 p.m. and ended at 5:25:28 p.m. The ratio was 1:2.

As Licensing observed the camera footage two residents were viewed sitting in the foyer area of the boy's floor. Licensing observed one of the residents get up (AO) and walk towards the door. It appeared to Licensing that words were exchanged amongst the two residents so the second resident (AV) decided to get up and follow the first resident by walking toward the door. Licensing was unable to hear the word exchange. Licensing observed the (AO) push the (AV) causing the AV to throw a book that he was reading.

Licensing observed the (AO) take his hand and hit the (AV) on the back of his head. Licensing observed the (AO) jump on top of a piece of decorative furniture to rest the feet.

Licensing heard through video audible (AO) said "come on bitch." Licensing observed the exchange of words that lead to the two residents fighting one another. Licensing observed that a male staff member did attempt to deescalate this incident in a timely manner.

Licensing observed it appeared that the staff monitored the residents for their safety and redirected the residents when needed.
