### **Narrative**

On 01/07/2025 at approximately 10:37 A.M., I was dispatched to a call for service for sexual abuse of a juvenile.

I made contact over the phone with Ms. Suzanne Roberts (complainant) from Crimes Against Children, who informed me she had received a report of sexual abuse of a juvenile. Ms. Roberts informed me she had received a report that JV1 (victim) is a patient at Little Creek Behavioral Hospital, and was sexually assaulted by JO1 (offender) who is another patient at the hospital and JV1's roommate. Ms. Roberts stated her initial report was that JO1 has been trying to date JV1, but she does not want to date her. JV1 reported to hospital staff that on 1/3/2025, JO1 picked her up, spun her around, put her on the bed, and then stuck her fingers into JV1's vagina.

Ms. Roberts stated she is trying to interview JV1 later today. I requested a report number from dispatch and gave Ms. Roberts a copy of the report number over the phone.
