Finding Description: A physical restraint ordered for one resident on 12/15/2024 at 1635 was signed by the physician three business days later on 12/18/2024. The current Corrective Action Agreement requires that the facility ensure all physician orders are signed within two business days following the order being given.

Action Due Description: The facility will continue to monitor all physician orders to ensure they receive the required signature by the ordering physician within two business days following the order to maintain compliance with the current Corrective Action Agreement.

Sub-Regulation Level 1 Description: Failing to comply with any stipulation or agreement with the Board involving probation or a settlement of any disciplinary matters;

Narrative:

The PRLU program manager reviewed the facility restraint log for December 2024. According to the restraint log 101 orders were given for seclusion, physical restraints, and chemical restraints during the month of December 2024.

A review of 1 record revealed that the resident had been ordered a seclusion, physical or chemical restraint 36 times in the month of December 2024 in response to 21 separate incidents. See below.

A review of the physician orders showed that the physician had signed the order for restraint or seclusion within two business days following the order, with the exception of one order (12/15/2024- Physical restraint

at 1635 was signed three business days later on 12/18/2024 by the ordering physician).

The facility is currently under a corrective action agreement with the Placement and Residential Licensing Unit. In that agreement, the facility is required to ".... ensure that all physician orders for restraints or seclusions are signed and placed in each resident's file within two business days following the order."

The facility will be cited for standard109.1.f Failing to comply with any stipulation or agreement with the board involving probation or a settlement of any disciplinary matters.
