Assault

On January 10, 2025, at approximately 12:51 p.m., Deputy Wharton and I responded to Youth Home, Inc. 20400 Colonel Glenn Road, Little Rock in reference to an Assault.

Staff member, Kennedy Goldman, reported she was bit in the right shoulder by [REDACTED] while trying to restrain [REDACTED]. Ms. Goldman said [REDACTED] was out of [REDACTED] assigned area. Ms. Goldman said she and other staff members advised [REDACTED] to go back to [REDACTED] area but [REDACTED] did not. [REDACTED] sat on the floor and began to kick, scream, and punch [REDACTED] in the legs. Ms. Goldman said she and the staff gave [REDACTED] multiple opportunities to get off the floor so that [REDACTED] could be escorted to the seclusion room. However, [REDACTED] was still refusing. Ms. Goldman said that she and another staff member grabbed [REDACTED] by the arms and escorted [REDACTED] to the seclusion room. Ms. Goldman did not have any visible injury. Ms. Goldman said she was provided medical attention by the Youth Home's nurse and that she was fine.

Ms. Goldman advised she wanted to pursue charges against [REDACTED] [REDACTED] was cited and released with the charge, Assault 3rd 5-13-207 C/M and court date for February 5, 2025 at 10:00 a.m at Pulaski County Juvenile Court. I took photos of Ms. Goldman's right shoulder and they are attached to the report. [REDACTED] said [REDACTED] had a bruise on the inside of [REDACTED] right arm from when [REDACTED] was being restrained. [REDACTED] said [REDACTED] was fine. I took photos of [REDACTED] and they are attached to the report. I made contact with [REDACTED] by phone and informed her of the incident. [REDACTED] advised she understood. The Youth Home advised they will be contacting [REDACTED] as well.
