while client [REDACTED] was sitting at desk. Staff intervened and separated clients. A few
minutes later as staff was coming to take client [REDACTED] to take to nurse Peer 2 [REDACTED]
stood up and struck Client [REDACTED] multiple times in the head and face. Staff intervened
to separate the clients. The client was taken to the nurse (Hannah W.). 2cm laceration noted
to area under right eye. No edema noted at this time to laceration area. Scant amount of
bleeding easily ceased with mild pressure, bruising, and redness noted. Laceration was
cleansed with wound cleanser. No active bleeding noted at this time. 1.5cm X 1.5cm nodule
noted to area above right eyebrow. Client evaluated, bilateral pupils equal, round, reactive to
light, and accommodative. Alert and oriented to self, time, place and situation. Client did
not lose consciousness during altercation per staff. MD notified. Transfer orders [REDACTED]
