Currently, [REDACTED] has been suspended pending further investigation.

Licensing inquired of the facility guardianship, witness statements, and nurse's note from the facility. Facility reported that they do not have witness statements, or a nurse note because the resident did not report an injury until several days later when random interview with him. 2/20/2025, per CHRIS case is pending.
