Regulation Description: Each written order for a physical restraint or seclusion is limited to two (2) hours for children ages nine (9) through seventeen (17) years, or one (1) hour for children under age nine (9) years. A physician, clinically qualified registered nurse or other authorized licensed independent practitioner shall conduct a face-to-face assessment of the child within one (1) hour after the initiation of the ordered intervention.

Finding Description: A face to face was not conducted within 1 hour of the restraint initiation time on 5 restraints which were conducted in the Month of January 2025.

Action Due Description: The facility shall conduct a face to face with all residents within 1 hour of the restraint initiation time.

Narrative:

A visit was conducted at the facility to review the following:

January 2025 Restraint log

3 files of residents with a high number of restraints and 2 residents that were admitted between October-December.

Physician orders for the restraints.

physician orders and restraint logs.

The M.A.R was reviewed for chemical restraints.

restraint packets were reviewed to ensure that all documentation is completed including the date, time, reason for the restraint, persons involved (including the name of the person who administered a chemical restraint), and monitoring of the child during/after the restraint.

Treatment plans were reviewed to ensure the plan was developed within 30 days of admission of the resident and that the plan is individualized to meet the specific needs of the resident. Treatment plans were reviewed to ensure the plans are updated to reflect the child's progress every 30 days.

Resident files were reviewed for [REDACTED] and [REDACTED] for restraint packets, physician orders, and accuracy to the restraint log. The M.A.R was reviewed for these residents to ensure chemical restraints were logged the day they were administered.

Resident files for [REDACTED] were reviewed for updated treatment plans, timeframes, and individuality.

Documentation for a face to face with the resident after a restraint, 1-hour from the initiation of the restraint.
