[REDACTED] exhibited aggressive and disruptive behaviors by instigating peers and yelling at staff during class. Client [REDACTED] then got in a physical altercation with 3 peers. Client [REDACTED] and his peers were separated. While in the classroom, Client [REDACTED] destroyed property via throwing and breaking a DVD player as well as breaking off part of the fixated projector. Client [REDACTED] was escorted by staff down to the transitional hallway in which he attempted to break open the fire extinguisher box and the telephone box. Program Consultant was called to the facility to assist with the client. Client [REDACTED] then proceeded to kick the door leading to the resident's hallway. Once client [REDACTED] was let in the hallway ; he spit on the door and window. Client [REDACTED] then broke the thermostat metal cover box and tore the thermostat from the wall. Client [REDACTED] put screws between his knuckles. As staff made attempts to see if client [REDACTED] was injured he walked toward staff with balled hands and began to spit. Client's therapist made attempts to calm client; however, client [REDACTED] verbalized threats and gestures to harm her as well. Due to the amount of property destruction, potential weapons (screws), and continued exhibition of aggressive, Bono Police Department (BPD) was called to the scene. BPD arrested client [REDACTED] and took him to [REDACTED] [REDACTED]. BPD was informed client [REDACTED] may return to the facility after stay in [REDACTED]. Upon return, client [REDACTED] will be placed on precautions as safety measures and for behavioral observation.

Police report received via email, uploaded, and specialist informed. 2.20.2025-Specialist emailed facility with follow up questions about damages, placement and precautions. 02.20.2025- Facility replied with the following: "All repairs were completed the same day the property damage was done. The resident returned to the facility Monday, February ██████. Upon return to the facility, ██████ was placed on Unit restriction and assault precautions for safety to reduce risk of harm to self and others. However, since returning ██████, ██████ has overall exhibited cooperative and compliant behaviors."
