### Narrative

ON 2/20/25 AT APPROXIMATELY 11:49 AM, I WAS DISPATCHED TO A CALL FOR SERVICE IN REFERENCE TO TERRORISTIC THREATENING AT 161 SKUNK HOLLOW ROAD (LITTLE CREEK BEHAVIORAL).

I MADE CONTACT VIA CELL PHONE WITH MS. JLYNN PERKINS (COMPLAINANT). MS. PERKINS ADVISED SHE NEEDED TO MAKE A REPORT IN REFERENCE TO A RESIDENT AT THEIR FACILITY. MS. PERKINS STATED ON 2/16/25 AND 2/17/25 JV1 (OFFENDER) WROTE LETTERS DURING FREE TIME IN BETWEEN LUNCH AND CLASS TIME. MS. PERKINS STATED JV1 GAVE THE LETTERS TO STAFF MEMBERS SHORTLY AFTER WRITING THEM. MS. PERKINS STATED THE LETTERS MADE STATEMENTS SUCH AS "AS SOON AS I GET ACCESS TO A GUN I'M SHOOTING UP A SCHOOL." MS. PERKINS STATED THE LETTER WENT ON TO SAY, "PREFERABLY WEST RIDGE HIGH SCHOOL IN BRISTOL TENNESSEE." MS. PERKINS ADVISED THE LETTER ALSO WENT ON TO STATE "I WILL SHOOT..." FOLLOWED BY A LIST OF SEVERAL INDIVIDUALS NAMES. MS. PERKINS THEN STATED ONE NAME WAS MENTIONED TWICE AND THE SECOND STATEMENT WRITTEN WAS "I FUCKING HATE EVERYBODY THERE, ESPECIALLY (JV2) I'LL BLOW HER FUCKING BRAINS OUT AND THEN FUCK HER CORPSE." MS. PERKINS ADVISED THE LETTER ALSO MENTIONED JV1 HAVING PREVIOUS CHARGES FOR MASS VIOLENCE.

MS. PERKINS ADVISED THEY HAD A CONVERSATION WITH JV1 ABOUT HER LETTERS AND THAT THEIR OFFICE WOULD BE DOING A REPORT.

MS. PERKINS ADVISED SHE DOES NOT KNOW HOW LONG JV1 WILL BE AT THE FACILITY, BUT THAT JV1 ARRIVED ON 2/12/25 AND A TYPICAL STAY AT THEIR FACILITY IS 275 DAYS. MS. PERKINS ADVISED SHE WOULD EMAIL A COPY OF THE LETTER TO ME.

I THEN GOT WITH DISPATCH AND GOT INTO CONTACT WITH SGT. NYGAARD (OTHERS INVOLVED) WITH THE SULLIVAN COUNTY SHERIFF'S OFFICE IN TENNESSEE. I ADVISED SGT. NYGAARD OF THE SITUATION AND ADVISED HIM OF THE SCHOOL THAT WAS NAMED IN THEIR COUNTY.
