On 2/24/25 at 1442 hours Officer Morris, Detective Morgan, and I were dispatched to Dacus Treatment

facility in reference to a disturbance in progress. After speaking with Staff over the incident Suspect 1 had made some racist remarks directed towards Trevin Johnson (staff) and a black resident. He was also claiming to be in the KKK. Trevin Johnson attempted to redirect the resident at which time suspect 1 charged Trevin and stood up in his face yelling at him to "say it again or else". Hannah Carr attempted to redirect the resident as well. It was at this time Suspect charged at Hannah and she was in fear for her safety. At this time Suspect started to destroy facility property. Hannah also commented on how large Suspect 1 is and their concern over their capabilities to control him when he is out of control. This is a second incident with this suspect see 25-00091. I made contact with Amy at juvenile office. After conversations with her and facility staff Suspect was transported to Craighead County Juvenile Detention Center.

On 2/24/25 at 1643 hours I emailed a copy of the report and statements to Amy Powell at Juvenile Office.

On 2/24/25 I, Officer Morris, was dispatched to Dacus (211 Church) in reference to a Juvenile threatening staff. Officers Morgan and McCracken also responded to the call. On scene, I made contact with Hannah Carr. Carr advised that S1 became violent and was charging at staff and making threats. Officer McCracken called the Juvenile Office and advised that S1 is going to be arrested on Assault 3rd degree. I went in the other room and advised S1 that he is being placed under arrest. I put handcuffs on him and double locked them without incident. I walked him to Officer McCracken's patrol vehicle and did a pat down there to make sure S1 had no weapons. S1 was placed in the vehicle and Officer McCracken transported.
