Report Description: Incident Report for [REDACTED] Private placement client in our PRTF program and resides in [REDACTED] House Incident Report date/time: 02/24/25 6:30pm Location of Incident: [REDACTED] House Incident Description: Suicidal Staff Involved: Jasmine Griffin, Joseph Davis Events Leading: i was doing phone calls and i called clients mom clients mom stated that [REDACTED] was disrespectful and hung up in her face yesterday because she told her no to bringing makeup for her. client got upset about that and went to her room about a hour later clients roommate came to me and told me to come here i walked in her room and client was tearful and had her sweatpants around her neck, client let me remove her pants from her neck and didn't really talk much i asked her why was she upset she stated it was because she wanted to talk to her mom and she feels her mom is being mean to her. Client wrote a last letter to mom stating she loves her but she doesn't want to be here anymore. I asked client can she come to the mileu with me and the client complied and came up to the mileu to sit with me. i called clients mom a little after the incident and mom stated she still doesn't want to talk to her and that she has to protect her peace and can't allow [REDACTED] to be disrespectful as that is the whole reason she's at youthhome. client appeared to calm down after meds and asked me to take a shower client was placed on eyeball and complied with keeping the door cracked to be monitored. Nursing Assessment date/time: 02/24/25 7:00pm: Client reportedly was in her room after a bad phone call with guardian. Client reportedly tied pants around her neck. Staff was able to remove ligature without restraint or injury. Client is nonverbal, looking downwards. Denies pain/injury, shrugs shoulders. Neck appears wnl, full active ROM to neck, no signs of injury noted. The tissue appears intact, there is no bruising noted. Client tearful, and agrees that she had a bad phone call. Encouraged client to be strong and confident, as this situation is temporary and suicide is a permanent solution to a temporary problem. Encouraged client to use healthy coping skills like exercising, reading, writing, walking and/or talking. Client did not contract for safety and was placed on eyeball, front of house,

and supportive status. A packet was printed out for her and placed near her bed. Client is resting quietly with eyes closed at this time. Guardian was notified on 02/24/25 at 10:15pm.
