Juvenile 1 was then placed into handcuffs (checked for fit and double locked) and charged with Battery 2nd. Juvenile 1 was then transported to Juvenile Detention Center and released to jail staff.

Pictures of Clark and Clark's statement form was attached to RPS and placed into the case file. A copy of report was emailed to Juvenile Officer Powell. Nothing further at this time.
