Description:

On Wednesday March 26, 2025 at approximately 19:41 hours I (Wills) checked en route to a battery report in the PD Lobby. Dispatch advised that a person wanted to report an incident in person.

I met with the victim later identified as Jermaine Burchett **Sector**) Jermaine stated that he was employed at Perimeter Health located at 2466 S 48th St. Jermaine said that he was attacked by one of the patients and wanted to press charges.

Jermaine stated that around 17:45 to 18:00 hours he was trying to get everyone into showers as part of the nightly routine. While doing so a female came up and started getting his face. Jermaine said that the female pushed him several times before he attempted to place the suspect into a headlock. Jermaine said that he was unable to secure the headlock and a fight ensued. During the fight Jermaine said that the female

grabbed his hair. Other staff members assisted in separating the two, and when they were apart the female had a handful off his hair. Jermaine said that the patient was not getting reprimanded for it and it was unacceptable behavior.

I asked for the suspects name and he said he could not legally provide it. Jermaine said that the suspect was a B/F approximately 17 YOA. Jermaine provided me the name and number to his supervisor and he said that she would try to help. I asked Jermaine if he would provide me with a written statement and he asked to complete it at home. I agreed and provided him a blank witness statement with the case number at the top. I asked when he was finished to bring it back to the station to place in the case file.

I then contacted the supervisor later identified as Sabrina McLellan **and the second s** 

I looked up the suspect's name in our database and found a local listed at the same address. I also contacted Jermaine again verifying that he did not have a medical license or certified by Arkansas as a medical professional. Jermaine advised me that he was only a mental health technician. I do not have any more information at this time.

4/8 0915 hours I called and spoke with Sabrina McClenan (supervisor) at Perimeter. I asked to verify that **a second second** (suspect) was a ward of the State; McClenan said she is. I also asked if she would provide me with videos of the incident if there were any available. McClenan advised me to go to the building and they should be able to provide me with a copy. I got in touch with Sales, Director of Risk Management, and she did show me the video of the incident. Sales said I needed to provide them with a subpoena to get the video footage of the incident. Sales also told me that she heard Burchett (victim) wanted to drop charges. I advised her that I will contact the victim to confirm what she heard. I left Sales with a copy of the subpoena, and was I was told they will contact me when the video is ready. I then called and spoke to Burchett, advised him that I was working the battery report he filed with us. Burchett then confirmed what Sales told me earlier at Perimeter. Burchett said he did not wish to press charges. I then asked if he was willing to swing by the Police station to fill out and sign the prosecution refusal form. Burchett told me he will be here on Wednesday, April 9th around 1300 hours.

4/10 0730 hours Burchett failed to show up yesterday to sign the prosecution refusal form. I am forwarding this case to my supervisor to be placed on inactive status./END/RA416

4/16 1000 hours I received an email from Mrs. Sales of the Perimeter Behavioral of the Ozarks stating that the video of the incident was ready to be picked up.
