The agency shall have a written plan for prescribing, receiving, storing, administering, and accounting for all medications, including medications in the child's possession at the time of admission.

The agency shall have a policy regarding each child's money received and shall ensure that each child's funds are available to that child, under staff supervision, for personal use.
