Narrative & Statements

Narrative - Carter, Tonya - 7/15/2025 8:53:33 PM (Initial)

On 7/15/2025 at approximately 19:24 pm, Officers were dispatched to The Centers for Youth and Families at 936 Jordan Drive in Monticello for a white juvenile male that left the premises. Upon arrival I spoke with a Mrs LaTrenda Hill who is a LPN at the Centers. She stated [REDACTED] was outside on the playground at 19:20 pm and climbed the equipment to get on the roof then jumped off the roof and traveled North into the wooded area. Mr [REDACTED] is a [REDACTED] white male, [REDACTED], He was last seen wearing a black t shirt, black nike shorts, and black shoes with white writing. Mrs Hill stated [REDACTED] came from [REDACTED].

At 21:15 pm dispatch received a call about a white male fitting this description attempting to hitchhike on Old Warren Rd. County units were notified and able to locate subject at 2124 Old Warren Rd. [REDACTED] was then returned back to The Centers.
